

Meritas Wealth Management, LLC (“we,” “our,” or “us”) is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ, and it is important for you to understand these differences. What investment services and advice can you provide me?

We offer investment advisory services to retail investors such as you through the management of your separate account. As part of our standard services, we monitor each account on an ongoing basis, using our current model portfolios as a guide, and we typically furnish clients with a quarterly report summarizing account activity, current position and performance analysis. Our authority to manage a retail investor’s account is discretionary, which means that you authorize us to select the identity and amount of securities to be bought or sold, subject to your chosen strategy and stated investment objectives. For most retail investors, we generally limit purchases to mutual funds and exchange-traded funds (“ETFs”). When we determine it is appropriate for you, we will also purchase publicly traded equity and debt securities. There is no investment account minimum to secure our services; however, we do require a minimum annual fee (see additional details in the following section – *What fees will I pay?*) Limitations on investments typically include limitations by plan sponsors, mutual fund selections of no-load or waived load funds, and client-imposed limitations. We also offer comprehensive financial planning services including but not limited to goal setting discussions, investment and retirement planning.

What fees will I pay?

We charge a fee based on the total assets in your account. This fee, which is payable quarterly in advance, is calculated from sliding fee schedules with an annual rate of 1% on the first \$2 million, 0.75% on the next \$3 million, 0.5% on the next \$5 million, and 0.40% on amounts over \$10 million in your account. There is a minimum annual fee of \$7,500 per client. The more assets there are in your account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Our fee does not include (and you will pay separately) any applicable charges imposed by custodians, brokers and other third parties such as brokerage commissions, transaction fees, custodial fees, wire transfer and electronic fund fees, and other fees and taxes on your account and on the securities transactions in your account. Money market funds, mutual funds, and ETFs also charge their own internal management fees. Fees for financial planning services are separate from our investment advisory service. They are billed based on hourly and fixed fee arrangements. Fixed fee arrangements typically total between \$4,000 and \$7,000 for a comprehensive financial plan. Hourly planning ranges between \$175 - \$350/hr. depending on the personnel we deem necessary to complete the client’s project(s).

- **Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?**

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Charles Schwab & Co, Inc.
